Counsel was informed this afternoon that Guardian, Carol Pickett intends to move the Protected Person today from his current Sierra Regional Center certified provider home to an uncertified provider home. Such a move requires 10-days' notice to the court and interested parties and may violate the Protected Person's Bill of Rights. Therefore, counsel submits this motion and proposed order to clarify the Guardian's authority to move Casey from his current placement. Because this intended move is imminent, this motion falls under the notice exception of Rule 43(2)(a). *Id.*
